

COPPER CAT® ROOF CLEANER

APPLICATION INSTRUCTIONS



ROOF APPLICATION:

Use on: Asphalt Shingles, Cedar Shake, Concrete Tiles, Clay Tiles, Slate, and Metal

Can also be used on: walkways, retaining walls, siding, fences, patios, patio furniture, pool decks, boats, RVs, docks, and more.

PRODUCT DESCRIPTION:

Copper Cat® Roof Cleaner (CCRC) with CO-OXIDE TECHNOLOGY™ is a scientifically formulated roof cleaner and restorer. It is designed to work with Mother Nature to clean and restore roofs without pressure washing. It contains no bleach, leaves no toxic residue, needs no scrubbing and will not harm people, pets, or plants under normal use.

Apply to a dry roof surface at 40 degrees and rising. Allow product to dry 45 minutes before forecasted rain or rinsing.

DIRECTIONS FOR USE:

1. Personal Protective Equipment: Wear safety goggles and gloves when applying CCRC.
2. Preparation: Remove any loose dirt or debris from roof surface before applying CCRC.
3. **Mixing the Activator:** Prior to application, add the liquid activator to the CCRC. Stir or gently agitate mixture for a few minutes. If mixed in CCRC container, **DO NOT REPLACE CAP AFTER MIXING.** Let stand 10 minutes for activation before use.
4. Pour activated CCRC into a plastic garden pump sprayer. **DO NOT USE METAL CONTAINERS OF ANY KIND!**
5. Apply CCRC liberally and evenly on the surface to be treated and let Mother Nature do the rest.
6. No pressure washing is necessary. However, after the cleaner has dried, you may perform a light rinse to remove any remaining debris. **USE EXTREME CAUTION AS ROOF SURFACE MAY BE SLIPPERY.**
7. Use activated product within 10 hours.

CAUTION, DO NOT LEAVE ACTIVATED PRODUCT IN CLOSED CONTAINER

Unscrew the plunger on spray containers to prevent dangerous pressure build-up
OR leave cap open when not in use.

When using on a surfaced other than roofs, always test a small inconspicuous spot to ensure product will not negatively affect the surface to be cleaned.

COVERAGE RATE:

1 Gallon / 100 - 150 sq. ft. of coverage depending on level of growth.

This product leaves no toxic residue. Which means NO BLEACH. It meets the USA (EPA) Environmental Protection Agency regulations and has the "SaferChoice" certification. It contains a proprietary formulated hydrogen peroxide base with an added activator to achieve a deep cleaning and desired results.



DANGER:
